School Philosophy, Educational Purpose, and Goals

■ School Philosophy

Nurturing truly internationally minded people through Kotokushin, or unbiased harmony

■ Educational Purpose

Intending to contribute to a harmonious society that respects cultural diversity, we foster students' understanding of Japanese culture, customs, and ways of life. Through this learning process, students develop their character and grow into true global citizens with a strong sense of public virtue, capable of contributing to peace and development in the international community.

■ Education Goals

- Achieve Japanese language proficiency equivalent to B2 level of the Japanese Language Education Reference Framework.
- Advance to the desired educational or career pathway (higher education or employment)
- Develop the ability to adapt to Japanese society.
- Cultivate a deep understanding of and respect for Japanese culture.

Characteristics of Our School

1. Full-Time Course Curriculum

In addition to the required Japanese language courses for full-time students, we incorporate elective required classes (JLPT preparation, EJU preparation, BJT preparation, and weakness reinforcement) into the standard curriculum.

As a result, students have increased study time, enabling them to overcome their own learning weaknesses and achieve their goals earlier.

2. Comprehensive Japanese language learning support system that provides multifaceted support for each student

We set up classes according to Japanese proficiency level, and each class is assigned a homeroom teacher who creates detailed lesson plans while considering students' attributes. In addition, for Japanese language subjects, we employ "team teaching," in which multiple teachers provide instruction so that students can interact with a variety of Japanese speakers. The homeroom teacher serves as a hub to ensure close coordination between the teachers who teach the same class, building a system to monitor the growth of each student from multiple perspectives.

3. Dedicated career guidance

We have established a comprehensive career guidance system led by homeroom teachers and career counseling staff. Through various guidance sessions and individual support, we provide meticulous career support for each student—from selecting target schools and preparing application essays to guiding them through the entire admissions process, including interview practice and post-acceptance enrollment procedures.

4. Affiliated Institution of the University

As an affiliated school of Tokyo International University, students are eligible to advance to Tokyo International University through a special recommendation system, which offers benefits such as exemption from entrance examination fees and tuition reductions as scholarship incentives.

Students also have opportunities to interact with Japanese students, including attending regular concerts by Tokyo International University's Wind Ensemble regular concerts and participating in international student speech contests held during the university's campus festival.

5. Providing many opportunities to learn Japanese culture

Clubs for flower arrangement, tea ceremony, calligraphy, and kimono dressing are available, offering students opportunities to learn traditional Japanese culture through club activities and understand the public virtues valued by the school. In addition to Japanese language education in the classroom, all students can participate in off-campus learning activities, including Kabuki and Noh theater performances and excursions such as walks in Koedo Kawagoe. Furthermore, as an affiliated institution of Tokyo International University, students are eligible to use the National Museum Campus Members Program, providing additional opportunities to appreciate art and culture.

School Location

The school is located in a quiet residential area, just a 4-minute walk from JR Takadanobaba Station in central Tokyo. With excellent transportation access—only 5 minutes to Shinjuku and 3 minutes to Ikebukuro by train—students can travel comfortably to all areas of Tokyo.

Takadanobaba is a town with a long history, and is also known for its vibrant, international atmosphere. With many international students and young people gathering in the area, it offers an ideal environment for learning and cultural exchange.

Special Bridge Program to Proceed to Tokyo International University (BP)

The Special Bridge Program to Proceed to Tokyo International University (BP) is a unique program offered exclusively by our school as an affiliated institution of the university. It is designed for students who wish to enroll at Tokyo International University but whose current Japanese language proficiency has not yet reached the level required for university admission.

For highly motivated students who consider Tokyo International University their first-choice institution and demonstrate strong academic motivation, clear goals, and a high level of awareness of social issues, our school takes full responsibility for developing their Japanese language skills and aims to support all students in gaining admission to Tokyo International University.

■ Benefits available at TIUJ

◎ BP admission scholarship

1. Full exemption from admission fee (100,000 JPY) for those who have 270 points or higher in the EJU Japanese section or who have passed JLPT N1 at the time of application.
2. Half exemption from the admission fee (50,000 JPY) for those with 240 points or higher in the EJU Japanese section or who have passed JLPT N2 at the time of application.
3. Students who have 220 points or higher in the EJU Japanese section or who have passed JLPT N3 at the time of application will receive a 50% waiver of the admission fee (50,000 JPY). This amount will be refunded once enrollment procedures at Tokyo International University have been completed.

◎ Study Incentive Support

1. The full examination fee for the JLPT taken while enrolled at our school will be covered (up to a maximum of 3 times).
2. The tuition fee for one subject will be covered from among the following basic subjects: English, Mathematics, Japan & the World, Physics, Chemistry, and Biology.

※The study incentive grant will be awarded upon completion of the BP program.

◎ Accelerated grade system to Tokyo International University

If you reach a Japanese language proficiency level of N2 or above by the time of the second entrance exam and if you wish, you can enter Tokyo International University even if you are in the middle of your Japanese language school course. In other words, depending on your efforts, you can shorten the period of study abroad for “Japanese language school + university” and save on tuition fees, living expenses, etc.

(*) If you change your career path and do not enter Tokyo International University, we may ask you to return the scholarship you received through the above benefits.

■ Course Features

This course is designed for students who have a basic Japanese proficiency at approximately the intermediate level. Its goal is to enable students to acquire, within one year, the Japanese language skills necessary for advancement to Japanese higher education institutions or employment in Japan.

■ Admission Requirements

Applicants eligible for admission must meet one of the following criteria and possess the Japanese language proficiency specified below at the time of admission.

- (1) Applicants who have completed 12 years of formal school education under a standard curriculum in a foreign country and are qualified for university admission in that country.
- (2) Applicants who have completed a secondary education program in a foreign country that qualifies them for admission to a university or other higher education institution.
- (3) Applicants who have been recognized by this school, in accordance with standards set by the Ministry of Education, Culture, Sports, Science and Technology (MEXT), as having an academic background equivalent to or higher than graduation from a Japanese high school.
- (4) Other applicants who possess, or can obtain, an appropriate status of residence in Japan, and who are deemed suitable for admission by the principal of the school.

《Applicants who are recognized as likely to possess the following level of Japanese language proficiency at the time of admission》

- **Students from Kanji-using countries:** Japanese language proficiency at CEFR A2(JLPT N4) level or higher
- **Students from non-Kanji-using countries:** Japanese language proficiency at CEFR B1(JLPT N3) level or higher, plus knowledge of approximately 650 kanji characters

This course is designed for students who have a foundational level equivalent to the latter half of beginner-level Japanese and aims to enable them to acquire the Japanese language skills necessary for entering Japanese higher education institutions or for employment within one year and six months.

■ Admission Requirements

Applicants eligible for admission must meet at least one of the following criteria and possess the Japanese language proficiency listed below at the time of enrollment.

1. Applicants who have completed 12 years of formal school education under a standard curriculum in a foreign country and are qualified for university admission in that country.
2. Applicants who have completed a secondary education program in a foreign country that qualifies them for admission to a university or other higher education institution.
3. Applicants who have been recognized by this school, in accordance with standards set by the Ministry of Education, Culture, Sports, Science and Technology (MEXT), as having an academic background equivalent to or higher than graduation from a Japanese high school.
4. Other applicants who possess, or can obtain, an appropriate status of residence in Japan, and who are deemed suitable for admission by the principal of the school.

■ Course Features

This course aims to provide students at the beginner level of Japanese with the Japanese language skills necessary for entering Japanese higher education institutions or securing employment, ensuring they acquire these skills from the ground up over a two-year period.

■ Admission Requirements

Applicants eligible for admission must meet at least one of the following criteria and possess the Japanese language proficiency listed below at the time of enrollment.

1. Applicants who have completed 12 years of formal school education under a standard curriculum in a foreign country and are qualified for university admission in that country.
2. Applicants who have completed a secondary education program in a foreign country that qualifies them for admission to a university or other higher education institution.
3. Applicants who have been recognized by this school, in accordance with standards set by the Ministry of Education, Culture, Sports, Science and Technology (MEXT), as having an academic background equivalent to or higher than graduation from a Japanese high school.
4. Other applicants who possess, or can obtain, an appropriate status of residence in Japan, and who are deemed suitable for admission by the principal of the school.

《Applicants who are recognized as likely to possess the following level of Japanese language proficiency at the time of admission》

- **Students from Kanji-using countries:** Japanese proficiency equivalent to CEFR A1(JLPT N5) or higher, with the ability to read and write hiragana and katakana without difficulty

Life in Japan

■ **When working part-time** (Permission to Engage in Activity Other Than That Permitted under the Status of Residence Previously Granted)

International students who wish to work part-time in Japan must obtain “**Permission to Engage in Activity Other Than That Permitted under the Status of Residence Previously Granted**”.

If you work without this permission, you may be subject to penalties and possible deportation. Therefore, be sure to obtain this permission before starting any part-time job and submit a “**Part-Time Job Notification Form**” to the school office.

Please also note that employment at establishments involved in the adult entertainment industry is strictly prohibited.

● **Permitted working hours are as follows:**

- **During regular academic terms:** Up to 28 hours per week
- **During long vacation periods (e.g., summer or winter break):** Up to 40 hours per week & 8 hours per day

If you have multiple part-time jobs, the total combined working hours must not exceed 28 hours per week.

■ **About accommodation**

Our school provides several affiliated student dormitories to ensure that students can live safely and comfortably. These dormitories offer secure and pleasant living environments.

All dormitories are located in quiet residential areas in the Tokyo metropolitan area, providing an excellent living environment. In most dormitories, a resident manager couple is on-site to support students’ daily lives, including security, hygiene management, and nutritionally balanced meals.

■ **Living Expenses**

According to a survey conducted by the Japan Student Services Organization (JASSO), the average monthly living expenses (excluding study and research costs) for international students attending Japanese language institutions in the Kanto region are 123,000 yen.

Food and housing account for the largest portion of expenses. In addition, about 30,000 yen per month should be expected for hobbies, entertainment, miscellaneous expenses, and transportation.
